MINOR CHILD LIABILITY WAIVER AND RELEASE FORM

THIS IS A RELEASE OF LIABILITY OF PARTICIPATION AND LEGAL RIGHTS — READ AND UNDERSTAND BEFORE SIGNING

In order to create a safe and positive environment for the participation of Minor children defined as children under age 18, in a virtual learning environment, minor children's online activity and participation must always be accompanied and supervised by an adult.

Parent/Guardian's must sign a Liability Waiver and Release Form stating they are supervising the minor child(ren) and responsible for their actions and safety while participating in STEM Montessori Academy of Canada - STEM International Academy of Canada (SMAC-SIAC), STEMTOPIA, CANADIAN INSTITUTE OF STEM INNOVATION AND ITS PARTNERS programs online.

Due to the nature of the program, seeing guest facilitators being sourced from all over the world to teach, facilitate, and mentor participating minor children, the supervising adult is responsible for the minor child's safety, location and virtual activities at all times. Minor children can NOT be left unsupervised while online in a virtual environment with a facilitator. Their actions, and behavior should always be monitored by an adult.

The SMAC-SIAC, STEMTOPIA, CANADIAN INSTITUTE OF STEM INNOVATION AND ITS PARTNERS's VIRTUAL PROGRAMS are parent / guardian supervised programming. _____(initial)

I agree to hold harmless, indemnify and agree not to hold liable the SMAC-SIAC, STEMTOPIA, CANADIAN INSTITUTE OF STEM INNOVATION AND ITS PARTNERS organization, its volunteers, Board of Directors, staff, contractors and representatives from and against any present or future claims, cause of action, loss or liability for injury to person or property, which said minor child may suffer or for which said minor child may be liable to any other person, related to said minor child's presence and participation in SMAC-SIAC, STEMTOPIA, CANADIAN INSTITUTE OF STEM INNOVATION AND ITS PARTNERS programming, resulting from any cause whatsoever, which may include but not limited to: risk of trauma, verbal abuse, undue mental health struggles, unwanted contact, cyber stalking, harassment, bullying, emotional or physical trauma, regardless of fault.

I understand and acknowledge that I am fully aware of and assume the risks of managing a minor child in a virtual environment (including but not limited to the risk of trauma, verbal abuse, undue mental health struggles, unwanted contact, cyber stalking, harassment, bullying, emotional or physical trauma, etc).

I understand that SMAC-SIAC, STEMTOPIA, CANADIAN INSTITUTE OF STEM INNOVATION AND ITS PARTNERS shall have no responsibility to pay for medical treatment and related costs if said minor child is injured or subjected to any trauma or abuse while participating in programming provided by SMAC-SIAC, STEMTOPIA, CANADIAN INSTITUTE OF STEM INNOVATION AND ITS PARTNERS.

In consideration of the services provided by SMAC-SIAC, STEMTOPIA, CANADIAN INSTITUTE OF STEM INNOVATION AND ITS PARTNERS and my desire for my minor child(ren) to participate in virtual programming provided by SMAC-

SIAC, STEMTOPIA, CANADIAN INSTITUTE OF STEM INNOVATION AND ITS PARTNERS, I _____ ;

a) agree to provide supervision for my minor child(ren)

b) acknowledge that

(i) those rules, instructions and directions are intended to promote the safety of both myself and others;

(ii) my failure or refusal to abide by those rules, instructions and directions can lead to the immediate revocation of my right to participate in SMAC-SIAC, STEMTOPIA, CANADIAN INSTITUTE OF STEM INNOVATION AND ITS PARTNERS programs without any right to refund of any payments made;

c) agree to fully and forever waive, release and discharge the SMAC-SIAC, STEMTOPIA, CANADIAN INSTITUTE OF STEM INNOVATION AND ITS PARTNERS organization, its volunteers, Board of

Directors, staff, contractors and representatives from any and all claims, actions, causes of action, demands, judgments, damages (including compensatory, general, special, consequential, exemplary and punitive), liability or obligations of any nature or kind, whether known at the time I or the minor Child(ren)'s guardian leave SMAC-SIAC, STEMTOPIA, CANADIAN INSTITUTE OF STEM INNOVATION AND ITS PARTNERS or which may arise or become known later, which accrue on account of, or in any way arise out of or in connection with my, the minor Child(ren)'s, guardian's, or my minor child(ren)'s participation in activities in SMAC-SIAC, STEMTOPIA, CANADIAN INSTITUTE OF STEM INNOVATION AND ITS PARTNERS;

d) I agree to indemnify and hold the SMAC-SIAC, STEMTOPIA, CANADIAN INSTITUTE OF STEM INNOVATION AND ITS PARTNERS organization, its volunteers, Board of Directors, staff, contractors and representatives harmless from and against any and all losses, liabilities, claims, obligations, costs, damages, and/or expenses whatsoever, including, but not limited to, any and all attorneys' fees, costs, damages and/or judgments directly or indirectly arising out of, or relating to my and the minor Child(ren)'s Parents' Guardians' acts or omissions while participating in any activities in SMAC-SIAC, STEMTOPIA, CANADIAN INSTITUTE OF STEM INNOVATION AND ITS PARTNERS;

e) acknowledge that there are foreseen and unforeseen risks associated with participating in activities of SMAC-SIAC, STEMTOPIA, CANADIAN INSTITUTE OF STEM INNOVATION AND ITS PARTNERS; examples include, but are not limited to, including but not limited to the risk of trauma, unwanted contact, cyber stalking, harassment, emotional or physical trauma as a result of online or virtual participation;

f) agree to accept and assume all of the risks that accompany participating in activities in SMAC-SIAC, STEMTOPIA, CANADIAN INSTITUTE OF STEM INNOVATION AND ITS PARTNERS and represent that my, the minor Child(ren)'s Parents' / Guardians', and my minor child(ren)'s participation in activities in SMAC-SIAC, STEMTOPIA, CANADIAN INSTITUTE OF STEM INNOVATION AND ITS PARTNERS is purely voluntary and we are electing to participate in activities in SMAC-SIAC, STEMTOPIA, CANADIAN INSTITUTE OF STEM INNOVATION AND ITS PARTNERS notwithstanding the risks; and

g) agree that if my minor child(ren) are accompanied in SMAC-SIAC, STEMTOPIA, CANADIAN INSTITUTE OF STEM INNOVATION AND ITS PARTNERS by the minor child(ren)'s caretaker, which is not myself or my spouse/spousal equivalent, that I and the minor Child(ren)'s Parents or Guardian will ensure that the minor child(ren)'s caretaker signs the SMAC-SIAC, STEMTOPIA, CANADIAN INSTITUTE OF STEM INNOVATION AND ITS PARTNERS Caretaker release form, and I and the minor Child(ren)'s Parents or Guardian will indemnify and hold the SMAC-SIAC, STEMTOPIA, CANADIAN INSTITUTE OF STEM INNOVATION AND ITS PARTNERS organization, its volunteers, Board of Directors, staff, contractors and representatives harmless from and against any and all losses, liabilities, claims, obligations, costs, damages, and/or expenses whatsoever, including, but not limited to, any and all attorneys' fees, costs, damages and/or judgments directly or indirectly arising out of, or relating to the minor child(ren)'s caretaker's presence and participation in any activities in SMAC-SIAC, STEMTOPIA, CANADIAN INSTITUTE OF STEM INNOVATION AND ITS PARTNERS. _____ (initial)

I expressly agree that this Release Form is intended to be as broad as is permitted by the laws Of country of Canada and if any portion is held invalid, it is agreed that the balance shall continue in full legal force and effect. I understand and agree that this Release Form shall be governed by the laws of Canada. I hereby consent on behalf of myself, the minor Child(ren)'s Parent or Guardian, and my minor child(ren) for any and all claims related to or arising out of our participation in activities in the virtual online programming by SMAC-SIAC, STEMTOPIA, CANADIAN INSTITUTE OF STEM INNOVATION AND ITS PARTNERS.

As myself and my minor child(ren)'s participation in virtual online programming by SMAC-SIAC, STEMTOPIA, CANADIAN INSTITUTE OF STEM INNOVATION AND ITS PARTNERS is voluntary, I agree to hold harmless and release all liabilities for any suggestive claims brought about by a first, second or third party individual or organization consisting of volunteers, staff, guest speakers, facilitators, Board of Directors or parents / guardians acting on behalf SMAC-SIAC, STEMTOPIA, CANADIAN INSTITUTE OF STEM INNOVATION AND ITS PARTNERS, or whom are participating in online virtual programming by SMAC-SIAC, STEMTOPIA, CANADIAN INSTITUTE OF STEM INNOVATION AND ITS PARTNERS.

I understand that SMAC-SIAC, STEMTOPIA, CANADIAN INSTITUTE OF STEM INNOVATION AND ITS PARTNERS does not provide supervision of any individual within a virtual online environment, nor for the National STEM Leadership Program participants. _____(initial)

Knowing the risks described above, I agree, personally and on behalf of the minor child named above, to assume all the risks and responsibilities surrounding the minor child's presence at SMAC-SIAC, STEMTOPIA, CANADIAN INSTITUTE OF STEM INNOVATION AND ITS PARTNERS. _____(initial)

I am at least eighteen years of age and have carefully read and freely signed this Liability Waiver and Release Form (Minor Child). I understand and agree that no oral or written representations can or will alter the contents of this document. I agree that this agreement shall be governed by the laws of the country of Canada and will carry jurisdiction across all provinces and territories. _____(initial)

I also agree, subject to the terms above, to RELEASE AND HOLD HARMLESS the Released Parties from all liabilities and claims that arise in any way including but not limited to the risk of trauma, unwanted contact, cyber stalking, harassment, abuse, emotional or physical trauma that occurs to the minor child during their time at SMAC-SIAC, STEMTOPIA, CANADIAN INSTITUTE OF STEM INNOVATION AND ITS PARTNERS, while online, and when participating in the virtual online programming by SMAC-SIAC, STEMTOPIA, CANADIAN INSTITUTE OF STEM INNOVATION AND ITS PARTNERS. _____(initial)

This includes any claim of the minor and any claim arising from the negligence of the Released Parties.

I hereby acknowledge and represent to SMAC-SIAC, STEMTOPIA, CANADIAN INSTITUTE OF STEM INNOVATION AND ITS PARTNERS that I have read and fully understand this Release Form, and understand that I have limited my rights and the minor Child(ren)'s Parents' or Guardian's rights to pursue a claim against the SMAC- SIAC community by signing this Release Form.
